- **Must be at least 23 years of age.**
- **Class 'A' CDL (Haz-mat certification optional).**
- **2 years verifiable tractor trailer experience within the last 7 years.**
- **No DUI/DWI in the last 5 years.**
- **Tractor must be able to pass annual FMCSA inspections.**
- **Must pass DAC background check.**

Any one of the following items will disqualify a potential candidate:

- ✓ **Refusal to undergo drug and alcohol testing.**
 - ✓ **Transportation, possession, or unlawful use of an identified controlled substance while on duty.**
 - ✓ **Leaving the scene of an accident while operating a motor vehicle.**
 - ✓ **Any felony involving the use of a commercial motor vehicle.**

- **Must be able to pass a DOT physical and drug screen**
 - **MVR must not have more than 7 points – this may include accidents, moving violations or any combination thereof.**
 - **Must supply past 10 years of employment history.**

REQUIREMENTS FOR LEASING TRACTORS

TRACTOR PAPERWORK (*CELTIC XPRESS PLATES-IL IRP*)

- Copy of the Title (or Title Application no older than 6 months). If the Title is in another person's name, we will need that person to fill out a Power of Attorney and Release of Revenue which will need to be notarized (we have those forms available). If the tractor is being leased from another company or individual, then we will need a copy of the Lease Agreement between the two parties.
- Bill of Sale
- Annual DOT Inspection from a federally licensed facility. If the owner operator cannot afford to get a new one, we will put the cost on our account as Celtic Xpress will pay for one inspection every year. (Inspections are required every six months.)
- Current 2290 is required with one exception.
 - If tractor was just purchased, a 2290 must be paid by the end of the month following purchase. (For example, if tractor was purchased any day in November, the 2290 must be paid by the end of December.)
 - Illinois requires that the 2290 be paid in the titled owner's name. Name on Title and 2290 must match.

TRACTOR PAPERWORK (*PERSONAL PLATES*)

- Annual DOT Inspection from federally licensed facility. If the owner operator cannot afford to get a new one, we will put the cost on our account as Celtic Xpress will pay for one inspection every year. (Inspections are required every six months.)

REQUIREMENTS FOR LEASING TRAILERS

TRAILER PAPERWORK (*CELTIC XPRESS PLATES*)

The **ONLY** way we can get Illinois plates for a trailer is if the trailer is already titled in Illinois. If it is titled in another state, we will need the Original Title sent to us in order to have it Titled in Illinois.

With an Existing Illinois Title

- Copy of the Title (or Title Application no older than 6 months). If the Title is in another person's name, we will need that person to fill out a Power of Attorney and Release of Revenue which will need to be notarized (we have those forms available). If the trailer is being leased from another company or individual, then we will need a copy of the Lease Agreement between the two parties.
- Bill of Sale
- Annual DOT Inspection from a federally licensed facility. If the owner operator cannot afford to get a new one, we will put the cost on our account as Celtic Xpress will pay for one inspection every year. (Inspections are required every six months.)

Celtic Xpress Assisting in Title Change to an Illinois Title

- Original Title in your name or the MSO showing that it was signed over to you. (Illinois will not accept a photocopy.)
- Bill of Sale
- Annual DOT Inspection from a federally licensed facility. If the owner operator cannot afford to get a new one, we will put the cost on our account as Celtic Xpress will pay for one inspection every year. (Inspections are required every six months.)
